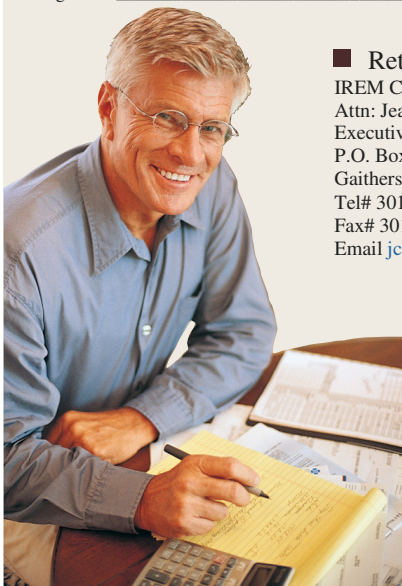

Friends’ Benefits
